### Learning Objectives

- Recognize current clinical guidelines for the management of pediatric asthma, including the appropriate identification of candidates for biologics therapies and the benefits of this type of treatment.
- Assess and identify early signs COPD in adults patients, by using appropriate screening tools and diagnostic criteria, applying evidence-based guidelines and develop management plans tailored to the individual patient needs.
- Apply techniques learned about individualizing asthma management plans for adult patients with asthma, taking into account variations in triggers, severity, and treatment response.
- Review evidence-based guidelines to adjust medications appropriately and educate patients on recognizing exacerbation signs and implementing action plans.
