Measure #	Description	
1	POs must meet specific participation targets to be eligible to earn a portion of the reward. Failure to meet any participation targets will result in no PO reward	
2	POs must meet specific participation targets to be eligible to earn a portion of the reward. Failure to meet any participation targets will result in no PO reward	
3	A PO Clinical Champion and Admin Liaison will be identified and designated within the INHALE Admin Portal within the specified time period outlined in the scorecard. PO Clinical Champion needs to hold a medical professional license (MD, DO, PA, NP, RN, RT). No non-licensed personnel may hold the clinical champion role.	
4	Provide valid email addresses for the Practice Clinical Champions and Practice Liaisons participating from your PO.	
5	Provide specified number of PO monthly calls hosted by INHALE. If a PO monthly call is not held/canceled, it will not count against attendance.	
6	PO Clinical Champions and PO Admins are required to attend the once yearly INHALE CW meeting for at least 75% of the meeting duration. A proxy may be requested but must be approved the by the Coordinating Center. If a proxy has attended the year prior, it may be denied, which will result in a loss of points.	
7	PO Clinical Champion or PO Admin logs into the INHALE Data Dashboard and reviews their PO/Practice performance.	
8	PO Clinical Champion or PO Admin will hold a QI based meeting (may be combined with regularly scheduled departmental/division meeting) to discuss topics, findings, data shared during the INHALE Collaborative Wide meeting. The meeting needs to be completed prior to the end of the measurement year. The agenda, attendees, and minutes will be submitted via the Admin Portal.	
9 & 10	Performance measure will be scored at the aggregated PO level for all INHALE participating practices (both PCP and SCP) in a PO. The 5% increase (inhaler ed) or 10% relative decrease (OCS overuse) will be calculated by comparing the rate during the measurement period to the baseline period (prior year). Either measure may be met, partially met, or combined to receive a maximum of 20 points. If the performance measure exceeds 20 points for meeting the target for one measure and partial target for another, the maximum awarded will be 20 points and any overage of points will not be added to the cumulative (participation portion) scorecard.
