





AAFA is committed to reducing the costs of asthma and allergy medications, including inhalers. We recognize that the high cost of these medicines can be a significant barrier to effective treatment.

In response to this issue, several major asthma inhaler manufacturers have announced a \$35 monthly cap on out-of-pocket costs. This price cap will benefit individuals with commercial / private insurance as well as those without insurance.
