



- Approximately 6 weeks until the VBR measurement period ends
- Ensure all participation activities completed!
  - Remind providers if have not completed L3
     requirement to watch on-demand videos in
     the INHALEarning and submit the Admin Portal Survey
    - The Admin Portal survey is required for credit!
    - CME is still available through Beaumont





## **Nomenclature Change**



- Aligning terminology across Pop Health CQIs
  - Cohort 1 = Continuing POs/Providers (Blue)
  - Cohort 2 = Onboarding POs/Providers (Green)
    - After first measurement year, will move to "continuing"

## **Proposed PO Scorecards Include:**

- Participation which may include:
  - Timelines for signing agreements
  - Identification of Clinical Champion/Admin Liaison
  - Attending meetings/calls
  - Reviewing the Data Dashboard
- Performance measure



### 2025 VBR



#### **Proposed PCP/SCP Scorecards Include:**

- Participation which may include:
  - Identification of Practice Clinical Champion/ Practice Liaison
  - Attending meetings, learning events
  - Reviewing the Data Dashboard
  - Conducting a case study
  - Sharing a best practice, feedback on a patient experience, etc
  - Present at a CW or Regional meeting
  - Participate in a site visit
- Performance measures including Tobacco Cessation



## **SCP VBR UPDATE**



## For SCPs to be eligible to receive VBR 3/1/2026:

- Specialists need to be in the January 2025 PGIP Snapshot, July 2025 PGIP Snapshot
   <u>AND</u> January 2026 PGIP snapshot
  - However, to be eligible for <u>future</u> specialist CQI VBR (effective starting with 2026 VBR, starting reimbursement date of 3/1/2026), practitioners <u>must be in each of the 3 below</u> PGIP snapshots.

	Snapshot	Date (i.e., 2026 VBR)	Verifies
1	1st Winter	January 2025	1-year engagement with PGIP
2	Summer	July 2025	<ul><li>Continued PGIP engagement</li><li>PO alignment for scoring</li></ul>
3	2nd Winter	January 2026	<ul> <li>Continued PGIP engagement</li> <li>Checks PO alignment again – so if switched POs, we share VBR results with the <u>new</u> PO although based on prior PO performance</li> </ul>

• This affects all SCPs who are currently participating and will be recruited this fall.



## **INHALE will be conducting site visits in 4Q24 and 2025:**

- Practices/POs may be contacted or volunteer for an in-person site visit.
- Aims include: sharing best practices, identifying efficiencies, education, etc
- Targeted time would be 1-3 hours but is flexible.
